Shrink Wrapping Services

Shrink wrap services will only be done at the shop on trailered boats – NO on-location or boat slip wraps available.



Please SHRINK WRAP my Boat / PWC. _____ Ft. x \$26.00 per ft. Boat will be wrapped below the tower or top unless otherwise discussed and confirmed with shop manager.

The integrity of shrink wrap is not guaranteed in winds over 50 mph and is only designed to last one season. Wraps are not intended to withstand road transport or winds over 50mph. Any boat with compromised shrink wrap left in dry lot will be removed completely to prevent any damage to surrounding boats and will only be re-wrapped at the owner's expense.

Battery Maintenance & Shore Power

We will not be responsible for dead or low batteries in the spring.

After winterizing, unless we have special instructions, all shore power cords will be left as we found them.

Boats remaining at the marina and on a lift through the winter will have their batteries left as follows unless otherwise noted: Boats with battery switches will be left in the off position with the battery still connected. Boats with no battery switch will have the negative cable disconnected. Boats not in slips will have their negative battery cable disconnected. PWC's will have their negative battery cable disconnected.

Fuel Storage & Holding Tanks

All holding tanks must be emptied before bringing boat in for winterization (see below). We recommend that your boat's gas tank be at least 80% full to minimize condensation and fuel contamination.

Holding tank pump out is required prior to winterization services being performed. If customer has not pumped their system out prior to our mechanic arriving at the dock, we will make every attempt to return the boat to the Marina for a pump out and then return it back to the slip. If this is necessary, there will be a charge of \$120 per hour plus a \$65 pump out fee. If the marina pump-out system is winterized, the customer understands that we will only add anti-freeze to the tank – however, a system that has not been pumped out is not guaranteed to be safe from freezing.

The customer is not entitled to recover from Jayhawk Marina, Inc., any consequential damages to the property, damages for loss of use, loss of time, or loss of profits or income.

I understand trailer locks, wiring extensions and adapters must be removed before submitting for service. Jayhawk Marina, Inc., will not be responsible for any trailer locks, trailer wiring extensions or adapters left behind. Locks left on trailers will be cut off.

Non-slip tenants: Service invoices must be paid, and boats must be picked up within 7 days of completion. An additional \$10 per day storage fee will apply to late pick-ups.
